# THE SOCIETY'S STRUCTURE & CONSTITUTION

SHARP is governed by an Executive Council (EC) of elected officers, a Board of Directors (chaired by Matt Kirschenbaum for the past year), and a Nominating Committee. SHARP's activities are made possible through the further efforts of numerous appointees (most obviously the editors of *Book History*, *SHARP News*, *Lingua Franca*, but also the various review editors, the moderators of SHARP-L, the DeLong Book Prize judges, and the archivist), as well as, of course, the membership as a whole. As always, we are very grateful to all those members who volunteer their time to support the Society. A wide range of members contribute in some specific volunteer role to enable SHARP to carry out its activities. If you would like to be more involved in SHARP, please contact any of the EC officers. I'd especially like to urge all of you to consider standing for election when we go to the polls in March 2023. The process actually starts with nominations from very early in the new year, so do keep in mind that important opportunity to help shape SHARP's future.

Finally, I would like to thank our two hard-working consultants: Executive Assistant, Ellen Barth, for her significant attention to the website, her assistance with the DeLong Prize process, and the many other research tasks she undertakes to help the EC make informed decisions, and Anna Muenchrath, our Coordinator of Communications who is undertaking a variety of less visible tasks, particularly in relation to redesign of our website, as well as overseeing our increasingly active Twitter feeds.

#### **PRESIDENT & VICE-PRESIDENT**

As of this meeting, Shef Rogers and Will Slauter have completed the first half of their second terms. Will has been very active representing SHARP in the American Council of Learned Societies (ACLS), from whom we gain a great deal of information and the opportunity to join other scholarly societies in shared initiatives, such as the Mellon-funded "Intention Foundry" that brings together emerging scholars, university administrators, and leaders of scholarly societies to envision ways to advance equity and inclusion in humanistic education and research.

Shef has served on the Finance subcommittee responsible for the report being for this AGM, along with Colin Ramsey, Lisa Maruca and Sarah Warner, and Danielle Fuller from the Board, who has chaired us so effectively. He is also switching gears slightly to convene the 2023 SHARP annual conference, which will be entirely online. SHARP membership is holding up despite not having been able to hold in-person conferences in 2020 and 2021 and and our finances are in good order. We are always eager to hear from members about anything you think we should be doing that we are not, or that we could do better.

After 2020/21 saw a flurry of changes in personnel and format surrounding our publications, 2021/22 offered consolidation and continuity - and cause for celebration! The journal *Book History* (eds. Greg Barnhisel, Yuri Cowan & Beth le Roux) is now in its 25th year, and three paperback issues have been published (24.1, 24.2, 25.1). We have received a lot of positive feedback on the transition to two paperback issues per year, and we are delighted to be able to share more content with you in this way. *SHARP News* (ed. Andie Silva, with a team of other contributors and editors) is fully open access and continues to explore new ways to engage with our membership and the book history community. *Lingua Franca*'s new editorial team (Cynthia Gabbay, Mariana de Moreas Silveira & Susan Pickford) is putting the final touches on their first issue together. As Director of Publications, I would like to express my deep gratitude to all the editors of SHARP's publications, as well as to JHUP for their involvement in publishing and distributing *Book History* to our membership and well beyond! Despite the ongoing pandemic and dire paper shortages in the publishing industry, our publications have continued to appear (almost) on schedule. We sincerely hope the SHARP community enjoys what *Book History*, *Lingua Franca* and *SHARP News* have to offer. #### AWARDS

Melanie extends her sincere thanks to the judges of the book prize, Kinohi Nishikawa, Susan Pickford, Jennifer Richards, and Daniel Bellingradt. This year saw the fourth award of the SHARP 25th Anniversary Fellowship to Chiara Betti (a Collaborative Doctoral Partnership PhD candidate between the Institute of English Studies/School of Advanced Study [UoL] and the Bodleian Libraries). This fellowship will support Chiara's research on the manufacture and use of 17–18th-century printing plates and the production of books during that time. In 2021 we also awarded the second round of research development grants for BIPOC scholars. The recipients were: DeLisa D.
